## **SECTION 4: OCL Graduated Approach**

Identifying children at SEN Support

Parents sometimes ask us to look more closely at their child's learning. We take all parental requests seriously and investigate them all.

Although the school can identify special educational needs, and make provision to meet those needs, we do not offer medical diagnoses.

### **SECTION 5: Plan and Do SEND provision**

All students, including those with SEND, should have access to a broad and balanced curriculum, underpinned by quality first teaching, where teachers plan appropriate learning outcomes for the students in their care. To achieve this at OA Henderson Avenue, we work on the basis that all children will be provided with to following as standard:

- Full-time education in the classroom with Quality First Teaching, differentiated for individual students
- Hover support in the classroom from dedicated Inclusion teams/ allocated Teaching Assistants (TAs) where appropriate.
- Encouragement to work as independently as possible with the right level of scaffold and support to access the same opportunities as their peers.

Exceptional Education at the heart of the Community



This means that children will predominantly spend their time in classrooms learning alongside their peers. We feel strongly that this promotes the best life chances for children with SEND.

## **Admission Arrangements**

We follow the Local Authority's admission policy.

#### **Transition**

At the end of each academic year teachers will pass on any SEND or medical information to the new class before the new academic year begins.

When children with SEND transfer to Secondary School the class teacher and/or SENDCO will liaise with the staff of the prospective secondary schools and hand over all SEND documentation prior to the new term beginning. Children with SEND will also receive additional transition work and sessions to prepare them for the move. The secondary school staff are invited to final EHC review meetings of the year 6 pupils.

Where children with SEND transfer to another primary school SEND records will be forwarded within 15 days of the child ceasing to be registered at our academy.



If a child transfers into the Academy during the academic year, the Academy will endeavour to obtain the child's records from their previous school as soon as possible.

If a parent or carer has any concerns relating to their child's SEND provision these should be addressed to, in the first instance, the child's class teacher and if further input is needed, the SENDCo, Mrs K Cliff.
